

Ford Power Promise[™] is extending into 2025!


Since launching the Ford Power Promise[™] in October 2024, customers in all 50 states are now filling up at home with their new Ford electric vehicle. Because of the positive customer response, effective January 3, 2025, Ford is extending the Ford Power Promise[™] program with complimentary home charger and standard installation through March 31, 2025.

Ford Power Promise[®] is a comprehensive, customer insights-led electric vehicle program providing convenience, peace of mind, and live advisors from day one of ownership. The extension of the program underscores Ford's commitment to removing barriers some customers face when making the switch to an electric vehicle, which can help save time and money.

Retail customers who purchase or lease a new 2024 and 2025 Mustang Mach-E, F-150 Lightning or E-Transit Cargo Van from a participating Ford dealer in the U.S. will be eligible for the Ford Power Promise[™] home charger and standard install offer.





By the Numbers

- Complimentary installations have occurred in all 50 states with Ford electric vehicle customers enjoying the convenience and potential savings of filling up at home.
- Since the program launched, the average timeframe from quote to installation of a home charger is 11 days, with an installation satisfaction score of 96%.
- 85% of complimentary charger installations have been fully covered by Ford at no extra cost to the customer.
- Customer access to electric vehicle support has increased with 24/7 Live Support enrollment up 487% YOY in December.
